Non-GRHOA Residents pay an additional fee of \$30.00 for the first league they register for in a season and \$20.00 for each league after the first registration. All resident players registered for teams on a first come/first registered basis and non-resident players are registered first come/first registered until maximum number of non-resident players is reached (1/3 of all registered players). All players and teams will follow USTA and CTA Rules and Regulations. All players and teams wishing to play on Governor's Ranch courts must be registered through the Association office.
